Thank you for participating in the public comment portion of the August 16, 2021 Thomaston Board of Education meeting. Your comments about the Connecticut mandate requiring masking in schools clearly indicated your position. Your comments have been recorded in the minutes of the August 16, 2021 Thomaston Board of Education meeting.

Connecticut Executive Order 13 continues the masking mandate originally put into place in Connecticut Executive Order 12a. The new Executive Order is in effect through September 30, 2021 unless extended, modified or terminated by the State. In anticipation of the termination or expiration of Executive Order 13, the Thomaston Board of Education Policy Committee has prepared an updated policy which would eliminate masking for students. This updated policy could be approved and implemented as soon as deemed appropriate by the Thomaston Board of Education. Executive Order 12a required the Department of Public Health (DPH) to list where masks would be mandated; the Conditions and Environments Requiring Universal Masking for the Prevention of COVID-19 indicated that "...all individuals, regardless of vaccination status, must continue to wear a face-covering mask at all times when...inside public or private school buildings (PreK-12)," so the local religious school you describe in your written comment cannot make masking optional or eliminate masking if the school is located in State of Connecticut.

Connecticut Executive Order 13d requires all school staff to be vaccinated by September 27, 2021 unless they provide and receive approval for a medical or religious/spiritual exemption from the vaccine mandate. At this time, Connecticut is not requiring the COVID-19 vaccine for students.

Thank you for participating in the public comment portion of the August 16, 2021 Thomaston Board of Education meeting. Your comments related to Governor Lamont's Executive Order 13d requiring vaccinations of school staff, Governor Lamont's Executive Order 13 extending the mask wearing mandated in schools, and your written comments related to attendance have all been recorded in the minutes of the August 16, 2021 Thomaston Board of Education meeting.

Executive Order 13d requires all school staff to be vaccinated by September 27, 2021 unless they provide and receive approval for a medical or religious/spiritual exemption from the vaccine mandate. At this time, Connecticut is not requiring the COVID-19 vaccine for students or athletes.

Connecticut Executive Order 13 continues the masking mandate originally put into place in Connecticut Executive Order 12a and is in effect through September 30, 2021 unless extended, modified or terminated by the State. In anticipation of the termination of Executive Order 13, the Thomaston Board of Education Policy Committee has prepared an updated policy which would eliminate masking for students. This updated policy could be approved and implemented as soon as deemed appropriate by the Thomaston Board of Education.

Student attendance related to quarantine was addressed after the public comment portion of the August 16, 2021 Thomaston Board of Education meeting through the <u>Thomaston Board of Education Resolution: Quarantined/Isolated Student Attendance</u>.
