6.2. IDEA Grant - Aimee Turner explained that the IDEA Grant is a federal entitlement grant which means we don't have to apply for it, but we do need to put together a plan on how we are going to use it. The Federal Government provides a certain amount of money to the State, and the State dissipates it to the towns. There are two sections to the grant. We are receiving \$216,335.00 for the 611 section, which is for Pre-K through 12 and we are receiving \$18,739.00 for the 619 section, which is just for preschool. Aimee Turner also stated that the last two years the department has been working on improving the teacher's knowledge on reading instruction, reading evaluation and reading intervention. The department feels that the district is in a really good spot. In the next two years we are going to work on system technology, since we have the one to one computing, we have a lot of students that could be accessing their education a little bit easier. These funds will go toward professional development and instructional supplies and about 90% of the funds are used for teacher's salaries. Next month we will be going over Title 1 and Title 3 grants.

Discussion: Superintendent Coss stated that going forward there will be more presentations of grants to the Board of Education, so the Board can approve the grant if necessary or so that the Board of Education can see the work that go into the grants and to understand were the numbers on the Business Managers report are coming from.

Superintendent Coss presented a hand out that includes overhead and street view photos, and some specks of the property located at 344 Watertown Road in Thomaston. Mrs. Broomhead contacted the First Selectman asking if the Board would be interested in purchasing the property since it is adjacent to Black Rock School. The First Selectman gave **Superintendent Coss** Mrs. Broomhead's contact information. **Superintendent Coss** stated that the property is not yet on the market, but Mrs. Broomhead would like to offer it to the town before putting it on the market, but she doesn't have a price yet because she hasn't had it appraised. If the Board of

Education shows an interest, **Superintendent Coss** would go before the Board of Selectmen and the Board of Finance, and request that they consider what the Board of Education would like to do with the property and then respond back to Mrs. Broomhead as to what the intentions would be. **Superintendent Coss** has walked the property and the driveway would connect through to Black Rock School as it stands now. The property would be in a place, that if we ever wanted to expand Black Rock School facility it would be a natural place to expand it in that direction. **Superintendent Coss** asked the Board of Education to take some time to discuss this and if the Board of Education feels that it is appropriate to take some action in moving forward with either attempting to purchase this property or not to purchase this property.

David Colavecchio said that this is information that needs to be digested, and he doesn't think that anyone is ready to make a decision. He also stated that he doesn't think the board should turn their back to it until the Board has heard the price of the property.

Superintendent Coss explained that Mrs. Broomhead would get it appraised if the Board of Education was to show an interest in the property.

Scott Theriault stated that he thinks it would be foolish not to entertain the idea. If the rest of the Board agrees, extend the interest and get on with the appraisal and go from there.

Kathleen Friemuth asked if it would ever be possible to have the Central Office housed there.

Superintendent Coss replied that it was not her intention and she would want to look at the cost of that due to the fact that Central Office is low cost right now. Other ideas have come up like the PATHS Program and office space to name a few.

Scott Theriault mentioned that even if it was purchased just to alleviate the parking lot issues, it would be worth looking into. And as a courtesy to Mrs. Broomhead the Board of Education should expedite the process and make a decision.

Scott Theriault moved and **David Colavecchio second** to move ahead with looking into the cost of purchasing Dr. Broomhead's property at 344 Watertown Road.

10.2.1. Presentations

10.2.1.1. Athletic Coach Hiring Protocol – John Perrucci

Kathleen Freimuth stated that John Perrucci presented the Athletic Coach Hiring Protocol. The discussion was based around the difficulty with coaches not having all of their material in on time. Part of the problem has been that it is easier for people who are internal to go into AppliTrack and upload their document. For people that external it has been more of a challenge. Part of it has been personal accountability for these coaches. There is a shortage for certain coaches especially at the middle school level. The discussion was also about Mr. Perrucci being proactive and having the documents to the Board of Education for approval prior to the season. Mr. Perrucci would also like to have a meeting set up with all the coaches, Athletic Directors, Superintendent Coss and himself to go over the procedures and forms that need to be completed for submittal. The coaches must submit their documents every year orthe AppliTrack system will erase them from the system. It has also been difficult not having a consistent Athletic Director. Mr. Perrucci is continuing to make updates to the Athletic Handbook.

Scott Theriault asked if they are going to have this meeting with the coaches.

Kathleen Freimuth explained this was a suggestion they had during the committee meeting.

Scott Theriault mentioned that there was an email that had gone out to coaches, but not all the coaches had received the email.

Superintendent Coss stated that is sounds like there is a need for a document, like a Google document with all

of the coaches contact information on it and **Superintendent Coss** will bring this to Mr. Perrucci's attention. **Superintendent Coss** stated we are in the processes of improving the procedures and the information Mr. Perrucci brought for his presentation were very positive.
