David Colavecchio motioned and Beth Campbell seconded to direct the Superintendent and/or the Business Manager, on Behalf of the Thomaston Board of Education, to Formally Request that the Thomaston Board of Finance and/or the Thomaston Board of Selectman Create an Unexpended Education Funs Account in Accordance with Connecticut General Statue Section 10-248a.

Discussion: Scott Theriault asked what the Board of Finance opposition was.

Superintendent Coss replied that there were two oppositions. One opposition was, can the Board of Education control the spending of the money anyway they want and the second was is the Board of Education going to inflate the budget by 1% so that the Board can have 1% put into the account every year.

Scott Theriault mentioned that if the 1% is allowed under state law and the Board of Education has a surplus from the budget that the Board of Finance approved, why would there be an issue.

Superintendent Coss replied because the statues says that the Board of Education cannot create the account and the Board of Education cannot dictate the rules of the account. The funding body creates and dictates the rules.

Scott Theriault asked Superintendent Coss what are her ideas for the rules.

Superintendent Coss explained that she would want to contemplate Capital, and Special Education overages.

Scott Theriault mentioned that it might be more beneficial to the Board of Finance because it would take away from another line they may have to put money into.

Beth Campbell asked who would decide who the deciding funder is.

Superintendent Coss said that the Board would have to look at the statues. Once Superintendent Coss has confirmation from the Board of Education, she will compose a letter to the Board of Finance with a carbon copy to the Board of Selectman.

Roxy Fainer stated that the Board of Education has been trying to set up this account since 2016.
