# Vote to accept/approve the Updated 2018-2019 Operating and Capital Budget as presented

**Beth Campbell motioned and Heather Patchell seconded** to accept/approve the Updated 2018-2019 Operating and Capital Budget as presented.

**Discussion: Superintendent Coss** explained that the current budget with the addition of the School Psychologist is a 3.95% increase. The Board of Education offered a retirement incentive package to eligible teachers. The minimum requirement for that plan to be executed required ten (10) participants. At the time of the deadline, four (4) applications were received. At the time of the Board meeting, without renegotiating that particular agreement we do not have any retirements to accept and to count as a reduction to the budget. If the Board were to accept the four (4) who have applied, the budget would be reduced by \$104,647.00. That is an estimate, making an assumption that three (3) of those staff would be replaced by a teacher that would be hired at a rate no hirer than a Masters Step 3 and one of those staff would be hired at a rate no hirer than a Masters Step 5. That would bring the budget to a 3.111% overall increase and for the town it would be a 3.246%.

**Superintendent Coss** stated that the value of the School Psychologist that was added to the budget is \$70,304.00. If the School Phycologist position was not added into the budget by itself (not including the retirements), the Board would be a 3.477% increase to the town and 3.329% increase overall.

If the value of the four (4) retirements and the value of the School Phycologist were removed from the budget, the budget increase would be 2.667% overall and 2.772% to the town. **Superintendent Coss** recommended to the Board that they consider taking action in

one of the following ways for this budget:

- Choose to accept the budget as presented at 3.95% and vote on it
- Choose to make a change to the budget
- Choose to table taking action on the budget until the next meeting

Maureen McMahon recommended tabling it, stating there are too many variables.

Frank Treglia recommended tabling it.

Superintendent Coss explained that the Board would have to amend the motion to table it.

**Maureen McMahon motioned and Beth Campbell seconded** to amend the motion to table the vote of the 2018-2019 Operating and Capital Budget.
