The Board of Finance is asking the Board of Education to tell the Board of Finance what the Board of Education would want to spend it on. The Board of Finance is in favor of the resolution, but are waiting on the rules. Superintendent Coss stated the rules that she is emphasizing is capital and maintenance of buildings; but, the Board of Education could also use it for emergencies such as a funds that are not budgeted for like a boiler that blew and the Board of Education would have to act urgently and not ask the tax payers for additional funds.

Chairperson Guay asked it the resolution is like a rainy day account.

Superintendent Coss replied that there has to be a purpose and the purpose would be capital, but if the Board needed it for an emergency, then the Board could go to that fund.

Frank Treglia mentioned that he too liked the idea to be able to go back to the Board of Finance for the approval to be able to spend the money in the future.

Superintendent Coss explained that the Board of Education proposed to the Board of Finance that the Board of Education would approve the spending and then go to the Board of Finance for approval, so that both Boards would show approval on their records.
