John Perrucci, explained to the Board that the reason he put forward three nominees was that due to the fact that the instructions were not clear regarding who to submit the applications to. All three candidates are awesome, and if he had to choose then he would follow the policy of one rising Junior and one rising Senior.

Superintendent Coss explained that the policy states one rising Junior and one rising Senior so the Board would have to illuminate one of the Juniors that were nominated. If the Board were to go with the motion on the table then all three students would be accepted.

John Perrucci stated that all three students are excellent students.

Roxy Fainer asked if the Board suspends it for one year, the Board is supposed to have a Junior and a Senior, then the following year will the board need to suspend it again.

Superintendent Coss replied that it is a one year term.

Roxy Fainer asked if the Board will have to kick someone off next year and go back to the Junior and Senior. **Roxy Fainer** stated that she has a problem with suspending the policy.

John Perrucci explained that is why there were two (2) options presented to the Board.

Superintendent Coss stated that if the motion on the table is the one that satisfies the Board, then the Board would end up with three (3) representatives and if the Board wants to continue their membership, the Board would end up with two (2) Seniors next year and then the policy would have to be suspended for one (1) more year.

Frank Treglia asked if all application were submitted on time.

Superintendent Coss replied yes they were all on time.

Jennifer Nolan asked for the present Student Representatives opinion on the matter.
